#### Message from SDC



Since its inception in November 2019, the Swiss Business-NGO-SDC Partnership has been an invaluable source of inspiration and innovation, and I am proud to celebrate the first anniversary of this unique platform.

Despite the many challenges that came with the Covid-19 pandemic, among them the temporary suspension of face-to-face meetings and limited networking possibilities, many of the planned activities took place as planned, and when I took up my position as Director of Cooperation in August 2020, I was very pleased to encounter such

a motivated group of people, eager to benefit from the many networking opportunities and joint activities.

At SDC in Cambodia, our focus remains on our three priorities development domains: Skills Development and Employment (SDE), Agriculture and Food Security (AFS), and Governance and Citizen Participation (GCP). Our development efforts are aligned with Cambodia's Rectangular Strategy. The added value derived from synergies created by the Swiss Partnership further enriches and guides our work. Only by partnering with other actors, most importantly the private sector and civil society, can SDC make a meaningful contribution to the development of Cambodia, the world at large, and help to achieve the Sustainable Development Goals as outlined in Agenda 2030.

In 2020, we were able to launch a first joint project with equal funding by Carrier Connect (a Swiss enterprise), HEKS (a Swiss NGO), and SDC. The project aims at the development of innovative and appropriate smart technologies for improved water management and disaster risk reduction. This is just one example that demonstrates the impact the Swiss Business-NGO-SDC partnership can have, and the kind of actors this platform can unite; resulting in shared challenges, but also shared success - and the development of innovative solutions.

This year, Federal Councillor Ignazio Cassis is expected to visit Phnom Penh on the occasion of the Asia-Europe Meeting (ASEM) summit hosted by Cambodia in early June. His mission will certainly be the highlight of the year, and we sincerely hope that travel restrictions and quarantine requirements will be lifted by then, and that the summit can take place as planned.

In addition, I hope that I will be able to meet many more members of the Swiss Partnership in 2021. SDC Cambodia will be designing the new Mekong Region Cooperation Programme 2022-2025 this year, which will not only be aligned with strategies of the Swiss government and the needs of Cambodia's most vulnerable population, it will also take into account the added value Switzerland can bring to the table, hence the Swiss Business-NGO-SDC Partnership will have its role in this process.

Last but not least, I would like to thank the members of the secretariat and their support staff for the excellent collaboration. I look forward to working with all members of the Swiss Business-NGO-SDC Partnership to achieving the goals we have set for 2021.

### About the Partnership

The Swiss Business–NGO–SDC Partnership was born out of an interest by the Swiss Development Cooperation (SDC) to bring together a diversity of Swiss actors in Cambodia. SDC's multistakeholder approach to development, engaging public, private, and non-for-profit organisations, is a key component for ensuring inclusive participation and shaping the country's future development. With this incentive, SDC, with the collaboration of Swisscontact, has organised the first Swiss Business–NGO–SDC Forum in November 2019 to promote partnerships and enhance collaboration in pursuing the goals of the Agenda 2030. The first Forum was positively received by Swiss businesses, NGOs and Swiss business owners managing private companies in Cambodia. The aim of this first event was to have a deeper understanding on what roles Swiss actors play in Cambodia and explicit the interest of development institutions to partner with the private sector. 43 participants met on November 6th, 2019 and agreed to:

- Establish the Swiss Business–NGO-SDC Partnership
- And that the Partnership will be led by a tripartite secretariat with a representative from each constituency

This first event was an excellent opportunity to break the barrier between the private sector and NGOs. Three main topics were discussed: (I) Opportunities for collaboration between Swiss NGOs and Swiss Businesses; (II) Challenges that Swiss NGOs/ Businesses face when working with different actors; (III) Solutions and next steps to strengthen collaborations.

With a successful initial momentum, the secretariat organised a second networking event in January 2020 with the presence of the newly appointed Swiss Ambassador, Helene Budliger. The purpose of this second Forum was to define and clarify the shared values, mission, and objectives of the Partnership. A logo was designed to formalise and give a visible identity to the joint initiative. In this second networking event four key elements were decided:

- 1. The shared values
- 2. The membership criteria
- **3.** Five objectives and their activities
- **4.** A joint project initiative launched by SDC

These four deliverables have allowed the Swiss Business–NGO–SDC Partnership to evolve into a group with activities being led by various members. This document presents the activities carried out in 2020 and those planned for 2021.

Finally, through this Partnership we want to test and prove that engaging actors from different sectors can be an efficient and creative way of "doing development" work. By bringing together Swiss actors in Cambodia from the private, public and non-for-profit sectors, we have the chance of creating innovative and synergetic relations and enhance Switzerland's visibility in promoting inclusive development.

### 2.2 Shared Values and Mission

The Swiss Business-NGO-SDC Partnership aims to create synergetic relations between Swiss Businesses, NGOs and SDC, and to enhance Switzerland's visibility in promoting Cambodia's inclusive development.

In order to achieve its mission, the following shared values are adopted:

- Work with a long-term vision and invest in sustainable change
- Care for the environment and the planet
- Be committed to develop human resources
- Act in a socially responsible manner
- Respect and apply good governance
- We have expertise that we are willing to share
- Dare innovation
- Be willing to lead and communicate our activities
- Work together in the frame of the SDGs and the 5Ps in Cambodia

#### 2.3 Membership Criteria

In order to join the partnership, the following criteria are required:

- Members need to be Swiss NGOs or Businesses that are operating or potentially interested to work in Cambodia
- Agencies that are registered in Switzerland and are currently looking to work in Cambodia
- Association having Swiss members and entities or businesses with Swiss managers. These criteria



require an endorsement from their respective owners

Having fulfilled these criteria, the new members will be approved by the secretariat

Progress made in 2020

#### 4.1 Progress on Objectives

The following section highlights the progress made under each objective in the year 2020.

#### **Objective 1:**

## Increase visibility of the Swiss Partnership to external audience and provide space where members can interact, support each other, and find creative ways to partner.

Objective 1 was led by SDC and Swisscontact along with the members Web Essentials, CARITAS, Connexio, International/Cambodia Bridges to Justice, Sika (Cambodia) Ltd, The Academy of Culinary Arts Cambodia (ACAC), International Committee of the Red Cross (ICRC), Humanity & Inclusion (HI), HEKS/EPER-Swiss Church Aid (HEKS) and Eurocham. This objective consisted of four main activities.

#### Activity 1: External communication: Facebook page



External Communications was led by Swisscontact in 2020. The Facebook page was started on March 16<sup>th</sup>, 2020. From then until Q4, there were 25 post updates and 337 new followers. Facebook posts were updated every Friday and Telegram groups to schedule Facebook posts was also organized.

#### Activity 2: Develop directory of members and key information

The development of members directory was led by Connexio which was updated and distributed to all members via email by SDC. The members were encouraged to utilize the membership directory for professional networking purposes. The membership directory currently resides as an excel spreadsheet, however there are plans to integrate it into an internal online platform.

#### **Activity 3: Key forum information**

The lead for the Key Forum Information was taken by Web Essentials. The main aim of this activity was to develop a platform to communicate and announce each other's activities. There were a few options that were considered for internal communications platform, and Slack was suggested, however, due to security constraints of SDC's intranet, the platform could not be finalized. Web Essential together with SDC continue exploring other possibilities.

#### Activity 4: Interaction with forum to share lessons

The main aim of this activity was to share lessons/challenges/ success from member's activities and organize events. In 2020, five events were held: i) the Partnership Networking event in January to identify activities for the Annual Plan 2020 which was also attended by **HE Helene Budliger Artieda**, Ambassador of Switzerland to the Kingdom of Thailand, the Kingdom of Cambodia, and the Lao People's Democratic Republic; ii) the second networking event in June to review progress of the Annual Plan and to gauge the impact of COVID; iii) the SDC Networking event at Sun&Moon in September, was organized in order to welcome the new Director of Cooperation of SDC; iv) Entrepreneurial Ecosystem System Workshop; v) Field visit to Smiling Gecko Farm was organized in October. 17 participants from 10-member organization were a part of the first field visit; and, vi) an Annual Planning workshop was organized

#### **Objective 2:**

#### Define partnership and initiative for a joint implementation.

Objective 2 was led by SDC and Caritas with the support from Damnoek Toek, Smiling Gecko, Hagar, WWF, Phnom Penh Climb, Dufry and AALA. This objective consisted of three main activities.

#### Activity 1: Finalize the joint project criteria

The joint project criteria were finalized.

## Activity 2: Disseminate information on project proposals

The main of this aim of this activity was to inform members on new calls for proposals. This was done via emails and other means.

#### Activity 3: Selection of the project

The Secretariat led the selection of the project. Three proposals were submitted in 2020, i) Localizing Application of Appropriate Smart Technologies for Sustainable Climate Resilient Water Resources Management submitted by Carrier Connect GmbH in collaboration with HEKS EPER, ii) The Green container Initiative (GCI) was submitted by WFF in collaboration with Sika and iii) The Covid19 Response Proposal submitted bv Phnom Climb Community gym. The Carrier Connect / HEKS-EPER proposal was selected as the one to start implementation in 2021.



#### **Objective 3:**

#### Joint annual plan for professional coordination

Objective 3 was led by SIKA along with the support from SDC, Swisscontact, Caritas and Nestlé. This objective consisted of three main activities.



#### Activity 1: Prepare annual plan 2020 and share it

The aim of this activity was to write up and disseminate the annual plan 2020 that illustrates the mission and values of the Swiss Business-NGO-SDC Partnership and explain what activities have been undertaken by the members. A meeting was held on January 28, 2020 Swisscontact led the preparation of the 2020 annual plan and shared it with the members of the partnership.

# Activity 2: Follow up and review the annual plan progress

The aim of the activity was to ensure that the annual plan activities are on track and draw up lessons learnt and suggestions for 2021. Under Activity 2, SIKA has tracked on the progress of the annual plan by activities under each objective.



#### Activity 3: Reflection and adjustment for year 2020-2021

The aim of Activity 3 was to organize an end of the year meeting with all members to review the activities, and reflect on improvements needed, lessons learnt, and brainstorm on new activities that should be undertaken in 2021. This activity was undertaken by SIKA. After a review and discussion to readjust some of the components had taken place in the secretariat.

#### Activity 4: Prepare the annual plan 2021

In order to prepare the annual plan 2021, the Swiss Business-NGO-SDC Partnership Cambodia Membership Survey<sup>1</sup> took place over the course of 6 days in November. 13 members participated in the survey. Over 92% of the members were satisfied with the activities of the Partnership. Members mentioned that the Partnership has served as a platform from where they can get exposure, helped to learn about the stakeholders in various sectors, provided opportunity to learn about different institutions which could help develop better partnerships in the future. The agenda





for the annual meeting was then developed based on the key issues highlighted in the survey.

Plan for 2021

The plan of the Swiss Business-NGO-SDC Partnership for 2021 was borne out of the reflections revealed during the members survey. The plan was then developed based on the feedback from members during the annual forum meeting in December.

#### **Under Objective 1:**

Increase visibility of the Swiss Partnership to external audience and provide a space where members can interact, support each other and find creative ways to partner, there are three activities that the Swiss Business-NGO-SDC partnership will focus on.

#### Activity 1: External communication: Facebook page (Visibility)

Under this activity a new set up for Facebook posts updates will be developed. SDC will be the communication focal point of Facebook content gathering. Members need to send their generated contents based on the Swiss Partnership Facebook Protocol. Reviewed contents will be posted on Swiss Partnership Facebook page. Hence, SDC will send monthly reminder to members for Facebook updates and will also conduct final review of content prior to posting. However, in case there is high traffic of content ideas for the post updates, a separate system to track and update the posts can also be developed.

#### Activity 2: Key Forum: To have an internal communication platform

SDC is working on identifying a possible platform for the Swiss Partnership. Once this is identified, all folder management system will be set up and organized, including the membership database and related information on the members.

#### Activity 3: Interaction with forum to share lessons (Networking)

Under this activity, there are plans to organize two types of events: **i) Small Events**: refers to informal gathering that will take place once a month preferably over lunch. It will be held on a costshared basis. During these gatherings, guest speakers could be invited. Information is to be shared on the various topics that are interesting to the members. In some cases visits to members could be arranged. **ii) Big Events:** There are plans to organize at least 2 big events, foreseeable in June and November 2021. The details of the event will be developed later after consultation with the members.

#### **Objective 2:**

**Define partnership initiative for a joint implementation**, there are two main activities that the Swiss Business-NGO-SDC Partnership will focus on.

#### Activity 1: Disseminate information on project proposals

Under this activity proposals could be submitted on a rolling basis. There will be a quarterly review of proposals. Information will be sent out via Facebook and during the monthly get-togethers.

#### Activity 2: Selection of the project:

No changes to the selection criteria of the joint projects, particularly, the cost-sharing criteria are made. Equal participation of all the partners is still required for the successful selection and in order to maintain the partnership element of the proposal.

#### **Objective 3:**

#### Joint Annual Plan for Professional Coordination

#### Activity 1: Prepare annual plan 2021 and share it

The aim of this activity will be to write and disseminate the annual plan 2021 that illustrates the mission and values of the Swiss Business-NGO-SDC Partnership. This report constitutes the annual plan for 2021.

#### Activity 2: Follow up and review the annual plan progress

The aim of the activity is to ensure that the annual plan activities are on track and draw up lessons learnt and suggestions for 2022. Under Activity 2, the secretariate will track upon the progress of each activity.

#### Activity 3: Prepare the annual plan 2022

Under this activity, inputs will be gathered from members to finalize the annual plan.

These partners work on a wide range of thematic areas such as access to health care services, food security, community development and empowerment, sustainable agriculture, basic education and gender equity.

### 2.7 Swiss NGOs in Cambodia

It is active in supporting vulnerable and marginalized children and their families in three different locations: Poipet, Neak Loeung, and Kep. We are helping street children an employment. Damnok Toek developed also a programe to help Children and Young People with Disabilities providing them with a home, healthcare, physical and occupational therapy, and education. DT takes care of about 1000 children daily with the support around 106 employees.
Empowering Youth in Cambodia	Empowering Youth in Cambodia (EYC) is a grassroots organisation based and registered in Phnom Penh, Cambodia working to improve the lives of young people and their families. EYC creates opportunities and support structures for vulnerable children and youth in four urban poor communities (slums), through extracurricular and after school activities in community-based schools. These programs, free of charge, represent a safe haven for the slum youth, coming home after school. The curriculum includes English classes, computer classes, leadership development, preparation for job placement, sports, music and art. Criteria to participate include only that students from the local community, from poor socio economic background, have a strong will to study and willingness to actively participate in EYC program activities.
HAGAR The whole journey	Hagar was founded in 1994 in Cambodia response to the prevalence of extreme domestic and community violence affecting women and children in post-civil war Cambodia. In 2008, Hagar expanded its unique model of long-term, individualized care in Afghanistan to support women and children facing the worst forms of gender-based violence and human trafficking. The following year, Hagar established an office in Vietnam to care for women who were affected by the growing magnitude of exploitation and abuse. More recently, Hagar began delivering programs for women through our support office in Singapore, and we are partnering with organizations in Myanmar to increase their capacity to provide Trauma-Informed Care.
HEKS	HEKS/EPER (Swiss Church Aid) was founded in 1946 as the aid organization of the Swiss Protestant Churches. HEKS/EPER combats the causes of hunger, poverty and injustice through its focus on inclusion, access to land and other natural resources and sustainable agriculture, and it provides emergency aid following natural disasters and armed conflicts. HEKS/EPER is active in 32 countries with 251 projects around the world. HEKS/EPER has been present in Cambodia for more than 30 years and focuses in Cambodia on food security, sustainable agricultural value chains, access to land, water and other natural resources, and good governance.
humanity &inclusion	Humanity & Inclusion is an independent and impartial aid organisation working in situations of poverty and exclusion, conflict and disaster. The organisation works alongside people with disabilities and vulnerable populations, taking action and bearing witness in order to respond to their essential needs, improve their living conditions and promote respect for their dignity and fundamental rights.

ICRC	The International Committee of the Red Cross is neutral, independent and impartial humanitarian organization with HQs in GVA, Switzerland and mandated to protect and to assist to victims of armed conflict, other situations of violence. In Cambodia the ICRC present since late sixties. Presently the Mission is focusing on development and capacity building in Disability, Detention and promotion of International Humanitarian Law (also known as law of armed conflict) sectors.
and a second sec	From 1992 to 2007, Dr. med. Beat Richner, the founder of the Kantha Bopha Hospitals, opened five children's hospitals in Phnom Penh and Siem Reap province. The five hospitals take care of about 85% of all the sick children in Cambodia. All treatments are free of charge with standard quality health services. The hospitals survived by funding from multiple sources: the Cambodian and Swiss governments, Kantha Bopha Foundation in Zurich, Cambodia Kantha Bopha Foundation in Cambodia, and contribution from individuals here and abroad.
<b>Le Don du Chœur</b> Cheur d'Entants des Ecoles Divudes Genevosses	The Don du Choeur association organises occasional concerts in support of a humanitarian project, where a choir of some 350 children from Geneva's private schools sing to raise funds for children in need. In this isolated rural Cambodian village, the school that was built in 2009, with funds raised by Don du Choeur, now has 550 pupils and is in its seventh school year. Our aim is to give the children a roof over their head, an education, a future. We are helped in this by a team of volunteer professionals, in the fields of education, health, management and communication.
LIGHTHOUSE - BATTAMBANG -	Lighthouse Battambang offers underprivileged, disadvantaged, aspiring Cambodians a brighter future through individual support, personal assistance and sustainable projects in the fields of education (high school & university), traineeship and agriculture.
Smiling Gecko®	In 2014 Smiling Gecko Cambodia (SGC) was founded as a local NGO in Cambodia. Initially, SGC had worked intensively with poor communities living in the dump sites, and slums. Addressing their difficulties and challenges, SGC has aimed to provide direct and sustainable support under the slogan 'Cambodians far Cambodians'. The goal is to promote know-how transfer, skill training, creating sustainable jobs, and finally realizing sustainable income generation for such desperate people. With its cluster project in northern province of Kampong Chhnang, SGC,s main focus, alongside direct assistance and support from other NGOs, is to provide training and regular income in the sectors of agriculture, tourism, industry, crafts, and basic education for children since very early age as our long-term investment.

Seed small beginnings	About 250 children profit from Seed's educational offers. A primary school and kindergarten in a remote village in Battambang province, and an English school at the outskirt of Battambang city, give the children from disadvantaged families a chance for a better future. Both schools also have well stocked libraries. Furthermore, with different water-filter systems and rainwater-tanks Seed is ensuring, that no kids have to suffer from illnesses caused by infected water. Seed also works together with diverse non-profits organisations and medical institutions, so that health care and emergency services are available to everyone.
SOLIDAR FIGHTING FOR GLOBAL FAIRNESS	Solidar Suisse is a civil society organization committed to achieving a socially, politically and economically just society. We fight for decent work, democratic participation and human rights in Africa, Asia and Latin America as well as South-East Europe. On behalf of our donors, we put solidarity into action in over 60 projects in four continents to create better possibilities and prospects for disadvantaged people. In Asia and Cambodia, Solidar Suisse specializes on the issue of decent work through its regional program, supporting unions, local CSOs and grassroots networks.
