The original documents are intended for the competent civil status authority in Switzerland and <u>must not be older than six months</u>. They can only be returned upon written request and before they have been sent to Switzerland.

Important: Photocopies and color scans legalized by a lawyer or other authority are not accepted. On request of the competent authorities in Switzerland, additional documents may be required

Legalisation

All foreign civil status documents must be legalised before being submitted to the Swiss representation. The apostille (Σφραγίδα της Χάγης) is affixed exclusively by the Ministry of Justice and Public Order

Translation

Documents that are not in a Swiss national language or in English must be translated. List of translators: https://www.pio.gov.cy/en/translations/

Interpreter/Translator

Persons who cannot fill in the required forms in a Swiss national language (German, French or Italian) must be accompanied by an interpreter/translator of their choice. The Swiss representation does not have a list of translators.

Fees

The fees for the preparation procedure are EUR 221.00, payable on the day of the appointment in cash or by debit/credit card.

Additional costs may arise if a document certification is required for foreign civil status documents in Cyprus that have to be certified by another Swiss representation. At the end of the procedure, an advance payment is required and a statement is issued.

Further information

All original documents must be accompanied by a photocopy.
The documents must be sent by registered mail or by courier service in order to prevent any loss.
The registration can take over 2-3 months, depending on the canton.
