	1 recent, good quality photo (glued to the application form). The photograph must fulfill Schengen standards, Size 3.5 x 4	
	Confirmed roundtrip flight reservation	
	COPY of Travel Medical Insurance, valid throughout the territory and the duration of the stay in the Schengen area. The minimum coverage of the insurance is of EURO 30'000.00. The insurance must mention SHENGEN on the territorial validity.  NO ORIGINALS	
	Personal invitation letter IN ENGLISH or an official language of Switzerland (an invitation form is not sufficient) duly signed by the inviting party with copy of valid passport/foreign residence permit containing the following details:	
	<ul> <li>Surname and name of the invited person</li> <li>Relationship degree between the two parties including documents proving family relationship if this is the case</li> <li>Exact duration of stay (arrival and departure date)</li> <li>Where the guests will be lodging</li> </ul>	
	ORIGINAL - Confirmation letter from the Kyrgyz employer containing position and salary of the employee, dates of his/her vacation and resume of duties after return Students are required to provide a confirmation of enrollment, indicating whether the travel is during school time. Self-employed applicants must provide a copy of their valid Kyrgyz "patent" and proof of tax payment for the past three years	
	ORIGINAL - Detailed PERSONAL bank statement showing all incoming and outgoing transfers for the last 3 months. A bank confirmation of assets is NOT enough.	
	COPIES of proof of civil status (marriage, divorce, death certificate) All documents must be translated to English NO ORIGINALS	
	COPY of the spouse's passport  NO ORIGINALS	
	COPIES of birth certificates for all children. All documents must be translated to English.  NO ORIGINALS	
	A list of personal properties (in English only). PROPERTY DOCUMENTS ARE NOT REQUIRED AND WILL NOT BE ACCEPTED BY VFS.	

Additional documentation for minor children (below the age of 18)	
COPY of birth certificate of the minor applicant NO ORIGINALS	
COPY of notarized consent form of the parent staying in Kyrgyzstan, signed by both parents  NO ORIGINALS	
COPY of custody decision if the parent is separated from the other parent of the child NO ORIGINALS	
COPY of death certificate if one parent has died  NO ORIGINALS	
Passport copies of both parents NO ORIGINALS

- Issuance of a visa does not guarantee entry to the Schengen area
