	<b>Original death certificate</b> including legalization done by the Ministry of Foreign affairs of Malaysia issued by the Ibu Pejabat.
	<b>Translation of the death certificate</b> into a Swiss national language or English by a sworn translator recognized by the Malaysian Ministry of Foreign Affairs. This translation has to be certified by the Malaysian Ministry of Foreign Affairs. If the death certificate is bilingual, no translation is required.
	Swiss passport and/or Swiss Identity card of the deceased (will be returned upon request).
All	original certificates and documents can be sent by post to the Swiss Representation in Bangkok.

#### Abstract of the family register

If necessary, an abstract of the family register can be ordered at the civil status office of the place of origin of the deceased approx. 5-6-5 weeks after the transmission of the death certificate. This document is requested in Switzerland for administrative procedures (such as insurance, survivor rent, banks etc.).

### Survivor's pension

If the deceased was registered at the Embassy, the Federal Old-Age and Survivors' Insurance OASI will be informed directly of its death. On the following link <a href="Form 318.000.2">Form 318.000.2</a> the spouse can apply for a Survivors pension. Once the document filled out and signed, it can be sent to our Embassy for transmission to the OASI.
