WHO IS THIS INFORMATION FOR ?	This information is destined for foreign citizens with residence in Romania who intend to travel to Switzerland for tourism purpose
	Fill out an online application on the following web-site: https://www.swiss-visa.ch/
4	Applications are to be submitted on a timely manner, maximum 6 months and minimum 2 weeks before the planned departure date.
	The following documents are mandatory together with the form:
	<ul> <li>Permit for residence in Romania, valid for at least 3 months after the date of expiry of the Swiss visa, original and copy;</li> </ul>
	<ul> <li>Hotel or other accomodation reservation;</li> </ul>
	<ul> <li>Bank statement (for the last 3 months);</li> </ul>
4	<ul> <li>Certificate issued by the company/ institution the person requesting the visa works for, listing his/ her position within the company. For students, a certificate from the faculty.</li> </ul>
	<ul> <li>Medical insurance for the duration of the stay (minimum amount of the insurance - 30.000 Euros for each of the following risks: hospitalization, emergency medical treatments, medical repatriation or death); The validity of the medical insurance must be at least 15 days longer than the length of the planned stay in the Schengen Area.</li> </ul>
	<ul> <li>Plane, train, bus, round trip ticket or the proof of reservation. In case you are travelling by car: the green card of the car;</li> </ul>
	<ul> <li>If visiting several Schegen countries, please provide a detailed itinerary of the planned trip</li> </ul>
	<ul> <li>Valid passport (at least 3 months after the date of expiry of the Swiss visa) and a good quality copy of the first page</li> </ul>
	<ul> <li>2 recent color photos, passport type;</li> </ul>
	The Embassy reserves the right to request additional documents at any moment. Important: If the visa request is refused, the fee will not be refunded.
	After filling out an application online, you will receive an automatic generated e-mail with a link that will allow you to book an appointment online at your convenience.
4	The forms and the other documents have to be submitted <b>in person</b> , by the holder, at the premises of the Embassy on the day of your appointment.
