**Processing time**

You can file your visa application at the earliest 6 months before the planned travel to Switzerland. Processing time is about 5 to 7 days but can be longer. The appointment list usually being booked solid for two weeks, you should start your application at least one month before traveling.

Adults and children above 12 years: 60'500 FCFA

Children between 6 and 11 years: 30'500 FCFA

In accordance with Art. 25a of the Visa Code (cooperation on the readmission of irregular migrants) and based on a report of the European Commission, Schengen area Member States decided to temporarily adopt an implementing decision with respect to The Gambia.

**Visa for official visits are free of charge**
