

## Birth of a child in the Republic of Korea to parents married to each other:

## entry in the Swiss civil status register

## Documents to submit

Children of Swiss citizen born in the Republic of Korea have to be registered at the civil status office in Switzerland. The Embassy of Switzerland in Seoul requires the following documents to be able to request this registration in Switzerland.

Submission of documents is possible with appointment or by post. Please contact the consular section of the Embassy by e-mail <a href="mailto:seoul.chancery@eda.admin.ch">seoul.chancery@eda.admin.ch</a> or by phone.

- If the birth has taken place in a national clinic, you may obtain the Apostille directly at Ministry of Foreign Affairs (MoFA).
- If the birth has taken place in a private clinic, the birth certificate must first be translated/legalized by a law firm and only <u>after that</u> you may obtain the Apostille.

Form sheet "Announcement of birth" for exact spelling of the names, add your contact details and exact transcription of the names of the parents from the Korean parent of the child. The transcription of the names has to be identical on all documents in accordance with the passports of the Korean citizens' parents. Both parents have to sign the form.

The original documents are submitted to the civil status authority concerned in Switzerland and <b>must not be older than three months. They will not be returned.</b> Photocopies are not accepted. Additional documents may be required if necessary.

Korean civil documents will be translated by the Embassy of Switzerland in Seoul.

Entry of the birth in the Swiss civil status register is free of charge.
Further information
☐ All submitted documents and certificates will be verified, legalized and forwarded to the competent civil register office in Switzerland. This procedure can take at least 2 months. Once the child is registered in Switzerland, a Swiss passport and/or Identity card can be applied through <a href="https://www.schweizerpass.ch">www.schweizerpass.ch</a>
$\hfill \square$ If the parents are registered as Swiss Abroad at the Embassy, the child will also be registered.
