UKRAINE'S HEALTH CARE SYSTEM IN URGENT NEED OF CHANGE

LOW EFFICIENCY SYSTEM



Although Ukraine spends a relatively high proportion of its GDP on healthcare in comparison with other countries in the region, key health outcomes are poor and lag far behind European averages. Life expectancy in Ukraine is almost 10 years lower than in EU.







OUT OF POCKET PAYMENT

The health system in Ukraine is hampered by inefficient allocation and use of resources and rampant corruption.

Today 1 out of 2 Swiss francs paid for healthcare treatment is informal or out-of-pocket. This is a major barrier for the poor and vulnerable to access health services and a major driver of inequity.



MAIN KILLERS

Today non-communicable diseases such as cardiovascular diseases and cancer are responsible for 90% of annual deaths in the country. Preventing and controlling these diseases requires greater public awareness of health, less tobacco and alcohol dependence, and better health services.

COLLAPSE OR REFORM

Action is urgently needed to avert a collapse of the healthcare system and to reverse the progressive deterioration of Ukrainian citizens' health status. The Ukrainian government has started an ambitious healthcare reform aimed at strengthening primary healthcare, health promotion and disease prevention, improving the efficiency of healthcare spending and enhancing medical practice. The main objective is to reduce mortality by 10 % by 2020.



«Health» is a longstanding priority domain

of Swiss cooperation in Ukraine. Swiss support aims at improving the health status of the population. Switzerland is supporting the government in both drawing up and implementing healthcare reforms. A specific priority is the prevention of noncommunicable diseases. Promoting healthier lifestyles, along with preventive measures, will help curb diseases such as cancer and diabetes, as well as cardiovascular and respiratory diseases disorders.
