Important information:

- Persons wishing to <u>return to Switzerland</u> within 2 months of contacting AWA BS/EURES will not be included in the database of job seekers in Switzerland. We recommend that you apply for jobs in Switzer-land before you return and to contact the <u>regional employment office (RAV)</u> at your planned place of residence <u>immediately after returning to Switzerland</u>. The regional employment office (RAV) is obliged to register your application and offer its services. Only complete applications will be pro-cessed.
- Unemployed persons currently residing in an EU member state may register at a regional employment office (RAV) upon arrival but are not eligible for any benefits under Swiss unemployment insurance. They must contact the relevant authority in the EU country and request their unemployment benefits be transferred to Switzerland.
